Appointment and Terms of Reference

On 3 February 2021, the Statutes Amendment (Repeal of Sex Work Offences) Bill 2020 – introduced to the Legislative Council on 8 April 2020 by the Hon T. A. Franks MLC following its Second Reading was referred to a Select Committee of the Legislative Council to inquire into and report.

Conduct of the Inquiry

During March 2021, the Committee advertised its inquiry in *The Advertiser*, *InDaily* and all regional newspapers inviting stakeholders to make written submissions or register their interest in appearing before the Committee and presenting evidence. Details of the inquiry, including links to the Bill and the inquiry's terms of reference, were placed on the Parliament's website.

In total, the Committee received 148 submissions (including one video submission). Of this total:

- 71 were for the Bill
- 74 were against the Bill
- 3 did not state a position.

Also 420 emails were received via one click politics.

The Committee commenced hearing evidence on 31 May 2021. The Committee met on 10 occasions to hear evidence from 29 separate groups of witnesses, most of whom had also provided written submissions.

Lists of submissions received and witnesses who appeared before the Committee are provided in Appendices A and B.

Objectives of the Bill

The Statutes Amendment (Repeal of Sex Work Offences) Bill aims to decriminalise all aspects of prostitution (referred to as Sex Work in the Bill) by repealing relevant sections of the *Criminal Law Consolidation Act 1935* (SA) and *Summary Offences Act 1953* (SA).

Criminal Law Consolidation Act 1935

The Bill seeks to amend the Criminal Law Consolidation Act 19351 (SA) by:

- Deleting the definition of 'common prostitute' from s 5(1) of the Act.²
- Deleting s 270(1)(b) from the Act which refers to an offence of 'keeping a bawdy house'.
- Inserting the wording 'offences relating to prostitution' to Schedule 11 of the Act under the heading 'abolition of certain offences' to remove this as an offence.

Summary Offences Act 1953

The Bill seeks to amend the Summary Offences Act 19533 by:

- Deleting the definition of 'prostitute' from s 4(1).4
- Deleting the word 'prostitutes' from s 21.
- Removing sections 25, 25A and 26 which read as follows:

25—Soliciting

A person who—

- in a public place, or within the view or hearing of any person in a public place, accosts or solicits a person for the purpose of prostitution; or
- (b) loiters in a public place for the purpose of prostitution, is guilty of an offence.

Maximum penalty: \$750.

25A—Procurement for prostitution

(1) A person must not engage in procurement for prostitution.

Maximum penalty:

For a first offence—\$1 250 or imprisonment for 3 months.

For a subsequent offence—\$2 500 or imprisonment for 6 months

- (2) A person engages in procurement for prostitution if the person—
 - (a) procures another to become a prostitute; or
 - (b) publishes an advertisement to the effect that the person (or some other person) is willing to employ or engage a prostitute; or
 - (c) approaches another person with a view to persuading the other person to

² It is worth noting the term 'prostitute' is defined in the *Summary Offences Act 1953*, s 4(1), as 'any *male* person who prostitutes *his* body for fee or reward'. [Emphasis added]. The use of *his*, a masculine pronoun, to define 'prostitute' seems nonsensical particularly because the definition was almost exclusively intended to refer to women. It does, however, reflect the widespread sexism in legal language at the time in which the legislation was introduced.

accept employment or an engagement as a prostitute.

(3) In this section—

advertisement includes a notice exhibited in, or so that it is visible from, a public place.

26—Living on the earnings of prostitution

- A person who knowingly lives, wholly or in part, on the earnings of prostitution of another person is guilty of an offence.
 Maximum penalty: \$2 500 or imprisonment for 6 months.
- (2) In proceedings for an offence against subsection (1), the fact that a person lives with, or is habitually in the company of, a prostitute and has no visible lawful means of support is, in the absence of proof to the contrary, proof that that person is knowingly living on the earnings of prostitution.
- Removing Part 6 relating to, among other things, keeping and managing brothels and police powers of entry and search of brothels.

Penalties

The current penalties under relevant legislation range from fines to terms of imprisonment depending on the offence type.

The relevant offences under the *Summary Offences* Act 1953 carry lower penalties than those offences under the *Criminal Law Consolidation Act 1936*. For example, the penalty for the offence of 'solicitation' is a maximum fine of \$750.⁵ A person who 'knowingly lives, wholly or in part, on the earnings of prostitution of another person' is guilty of an offence where the penalty can range from a maximum fine of \$2,500 or imprisonment for 6 months.⁶ However, the offence of 'keeping a bawdy house' carries a maximum term of 2 years imprisonment.

Committee Statement

Members of the Committee held divergent views, with some being supportive of the Bill, while others were not.

A majority position on the substantive contents of a report could not be established, nor could the Committee make any recommendation in regard to the passing of the Bill.
