## Watts Ward with Cr Moira Deeming

I am pleased to confirm that my two Notices of Motion, about the Government's **plans to allow public sex work and home based brothels**, and to reduce community consultation powers, were passed almost unanimously,

In my first Notice of Motion, I asked that Councillors support a **community awareness campaign about the State Government's plans to allow sex work to be conducted on public streets and operate out of homes.**

Thankfully, **the majority of Councillors share my concerns** that street band home based sex work will negatively impact families, children, businesses. Further, we believe that the changes will not achieve the worthy goal of increased safety for sex workers, but will instead reduce vital police, health, and counselling resources available to the vulnerable within the sex industry.

We feel a responsibility to ensure that the views of our community are heard and invite residents to complete a brief survey at <https://conversations.melton.vic.gov.au/sexworksurvey> on this matter.

The second relates to the Victorian Government's proposed changes to the State planning system which have begun removing the community's rights to be consulted and to lodge appeals against significant planning applications, as well as erode Council's planning powers.

Council will work together other Councils, growth area networks and the Municipal Association of Victoria to advocate for the rights of residents and Councils to have a say in what gets built in our areas.
